## Cumberland United Soccer Club Travel Waiver and Indemnity Agreement

I understand that my child is participating in transportation services provided by Roxborough Bus Lines and will thus fall under Roxborough Bus Lines' rules, regulations and insurance policies. As such, I hereby release the CUSC from any and all liability for any damages, loss or theft to my child's personal property, which may occur during or before transportation to the training facilities.

I understand that it is my child's sole responsibility to be at the bus stop on time and to board the bus safely with his/her bus pass available for inspection if requested. During the bus ride my child will abide by all rules and regulations as outlined by Roxborough Bus Lines, and will uphold the highest standards of behavior while aboard the bus. While on the bus, I understand that my child is the responsibility of Roxborough Bus Lines and is covered under the Bus Lines' insurance policy. The CUSC is in no way responsible for any injury or harm that may arise before or during my child's transportation aboard the bus, and CUSC may in no way be held liable for anything that arises before or during my child's transport to training sessions or games.

As a condition of entering into this Agreement and signing this Waiver and in consideration for participating in this program, and other valuable consideration, the receipt and sufficiency of which consideration is acknowledged, I \_\_\_\_\_ (parent's name) agree to indemnify and hold harmless the CUSC and its employees, volunteers, members, coaches, directors and trustees from and against all claims, damages, losses and expenses, including but not limited to legal fees, in any action arising out of the incident during the transportation of my child(ren) which causes personal or bodily injury, illness or death, property damage, including loss of use, even if it is caused in whole or in part by my child(ren)'s negligent act(s) or omission(s) or that of a CUSC subcontractor, or employee.

## Cumberland United Travel Agreement

### After school transportation services from the school to the training facility

By signing below I understand that:

1. It is my child's responsibility to be at the bus stop for pick-up on time, as per the schedule that is posted and provided to me;
2. It is my responsibility to check my email notices, Team Snap reminders, and/or website updates regularly for any schedule updates throughout the year;
3. The school bus transportation will run only on regular school days when regular school buses are running, and only on days when there is training as per the training schedule provided;
4. It is the parent's responsibility to pick up their child from the training facilities at the end of every practice or game;
5. It is the parent's responsibility to arrange transport to and from:
  - a. Any training sessions or games held on weekends; and
  - b. Any training sessions or games that start after 5:00 p.m.;
  - c. Any training sessions held on non-school days, which includes but is not limited to:
    - i. School holidays when training may still be scheduled;
    - ii. PD days when schools are closed but training may still be scheduled;
    - iii. "snow days" or "inclement weather" days when either schools are closed, or school bus services are cancelled (training may or may not be cancelled on such days, but transportation will not be provided regardless); and
    - iv. Regular school holidays when schools are not running i.e.: Summer holidays, March break, Christmas break, etc.
6. If there is no training scheduled for a particular day, no transportation will be provided.

Furthermore, I agree to alert the CUSC by emailing ([competitive@cumberlandsoccer.com](mailto:competitive@cumberlandsoccer.com)) on any days that my child will be absent from Training **AND/OR** will not be taking the bus.

I have read and understand the above Agreement and agree to abide by the CUSC rules.
